3.40 Practice, practice: a biosecurity response exercise

Biosecurity investigators have found something that is not wanted in New Zealand. Industry and MPI have initiated a response. Now they have to decide on a course of action.

This desktop exercise simulates a response strategic leadership (RSL) meeting. RSL members – drawn from Forum participants – will discuss a mock response brief presented by a response manager and decide what action to take. Delegates, who will observe the RSL deliberations, will vote on their preferred course of action. This workshop will help delegates understand what is involved in RSL and prepare them for making decisions during responses.
